## NOTICE OF RECOMMENDATION OF INTENDED DECISION

The College's RFP#10-20-21\_Continuing Services Contracts for Miscellaneous Projects/Architectural Services was issued on Monday, June 21, 2021 at 2:00 pm by posting on the St. Petersburg College Purchasing website, State of Florida Supplier Diversity website and emailing directly to thirty-nine separate vendors.

Three addenda were issued on this project. Addendum 1 addressed the Q&A portion of the proposal; Addendum 2 was a correction to the amounts listed for FL Statute 287.055(g), and Addendum 3 announced the five shortlisted responders. All were sent directly to the vendor contact list, and posted to the SPC Purchasing website and the State of Florida Vendor Bid System.

By the RFP deadline of Friday, July 30, 2021, the College received fifteen proposals.

Based on the combined scores of the five-person committee, the five shortlisted responders were announced via Addendum 3 on Friday, August 13, 2021.

After further consideration of the remaining proposals, coupled with the continuing nationwide delay for goods and services caused by COVID-19, the college has decided to exercise option (D) of the Selection Process (pg. 13 of the proposal) to forego the presentations and retain the services of all five shortlisted candidates.

A copy of this notice is also posted on the State of Florida's Vendor Bid System.

Our sincere thanks to all who participated in this proposal process.

NOTE: Failure to file a protest within the time prescribed in Section 120.57(3), Florida Statutes, shall constitute a waiver of proceedings under Chapter 120, Florida Statutes. Saturdays, Sundays, and state holidays shall be excluded in the computation of the 72-hour time period.
